

All our electrical, gas and plumbing work has to be carried out by properly certificated tradespeople, but there is plenty of scope for people who are interested in traditional skills, such as thatching and stone work. There are plenty of opportunities for painting, gardening and planning at the hostels and support activities behind the scenes.

#### **Our Simple Hostels**

Our hostels are for walkers and cyclists travelling alone or with one or two companions. They are ideal for families with adventurous children. All our hostels are converted croft houses. They are simply built stone houses with two or three rooms. Two of our hostels are thatched.

We provide comfortable bunk beds in dormitories heated by electricity, a well-equipped members' kitchen with a fridge, microwave and cooker, a friendly common room with a multi-fuel stove, books and games and, of course, a shower and toilet.

We provide no private rooms. Please do not expect luxury but do expect a comfortable well equipped hostel which is wind, weather proof and cosy. We are open 24/7, 365 days a year. Our doors never close.

#### No advanced booking

We take no advanced bookings but you will not be turned away. Our hostels are rarely full. They act as places of refuge on wet and windy nights. We cannot predict usage even at the last minute.

When you arrive at the hostel find an empty bed and make it with your sleeping bag (or hire a bag from the hostel). The bed remains yours for the duration of your stay.

#### **Being a Member**

Members receive our newsletters which keep them up to date with the hostels, the islands and volunteering opportunities. They are also invited to our Annual General Meeting and members' forum.
